Dear Friends,


Our 2019-2020 season is one we will not soon forget. Just nine days after the BWY in CLE Launch event announcing our next KeyBank Broadway Series, the COVID-19 pandemic halted performances at Playhouse Square and throughout much of the country.

When Ohio's ban on mass gatherings was enacted on March 12, 2020, the run of *Jesus Christ Superstar*, featuring a live theatrical surround-sound experience that would occur only in Cleveland, had just opened at Playhouse Square. Not knowing how long the shutdown might continue, we debated whether to leave the set on the Connor Palace stage. It turns out we and the producer made the right decision to pack everything up.

More difficult decisions would follow rapidly. When and for how long should performances be canceled or postponed? How best to communicate with affected ticket holders? How to transition our staff to working from home? How to control expenses, which would come to include workforce and salary reductions?

Our decisions were informed by tremendous support from our Board of Trustees, experts from University Hospitals and the Cleveland Clinic and guidance from our legislators. We are grateful to all of them for the time and wisdom they have offered and continue to share with us.





As May 2020 turned to June, the whole country witnessed the ignition of long-smoldering injustice and inequality in our Black and brown communities. Standing united with more than 100 Northeast Ohio organizations, we pledged our support for the Cleveland City County legislation declaring racism a public health crisis and our commitment to set forth tangible actions to undo systemic racism. As part of our commitment, we have introduced a Social Justice Series as part of our Streaming Performances for Schools lineup. This is just the beginning of our work.

While the conclusion of our 2019-2020 fiscal year was tumultuous, our accomplishments were many, both before and during those final months. Among the most notable, we announced the move of the Cleveland International Film Festival to Playhouse Square, celebrated the topping out of The Lumen apartment tower and launched “Playhouse Square at Home” to keep audiences engaged.

One of our proudest days at Playhouse Square was August 31, 2019 when we held our first Broadway sensory-friendly performance with Disney’s *The Lion King*. Welcoming families to the theater, many for the first time together, is an experience we will always remember. Please continue to read through this report for additional highlights.

Thanks to decades of prudence and long-term planning, Playhouse Square was fortunate to be in a position of strength when the pandemic struck. Our entrepreneurial spirit in facing challenges head on, along with the outpouring of support we have received, will enable us to emerge stronger than ever.

The remaining Playhouse Square staff members have risen to this occasion. They have served more than 60,000 households with tickets to canceled or postponed performances; and are staying connected to our season ticket holders, donors and RedCoats; taking care of the historic theaters; communicating with our resident companies and district businesses; and finding creative new ways to fulfill our mission. Our team at the Crowne Plaza Cleveland hotel quickly found ways to safely serve guests, and our Real Estate Services operation continued maintaining our properties and proactively working with our tenants to meet their needs.

The dedication and enthusiasm of our trustees, season ticket holders, donors, volunteers and members of the community keep us hopeful and energized. We are eager for the day when we can once again share the joy of live performance. Until then, we remain steadfast in our not-for-profit mission and keep our eyes on the horizon.



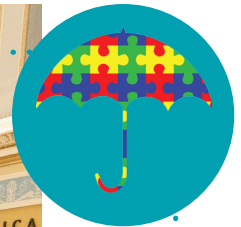

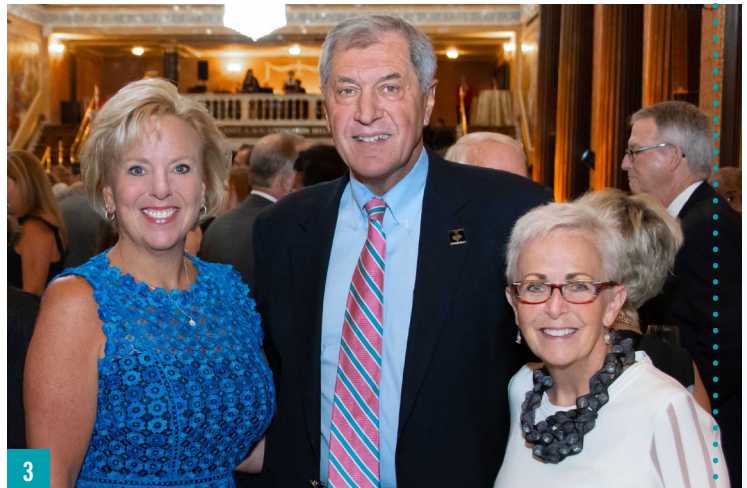

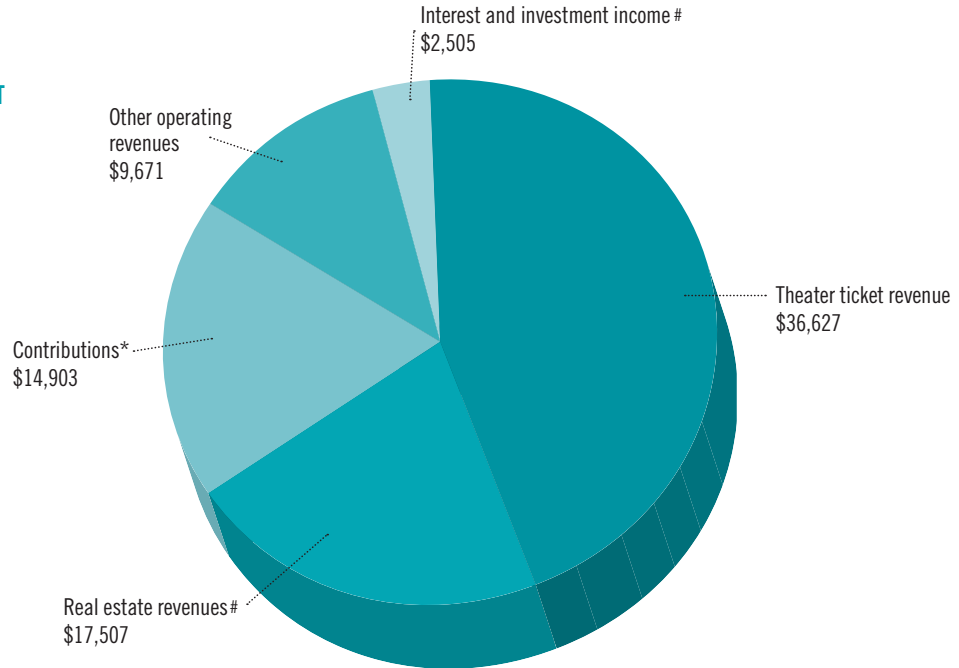

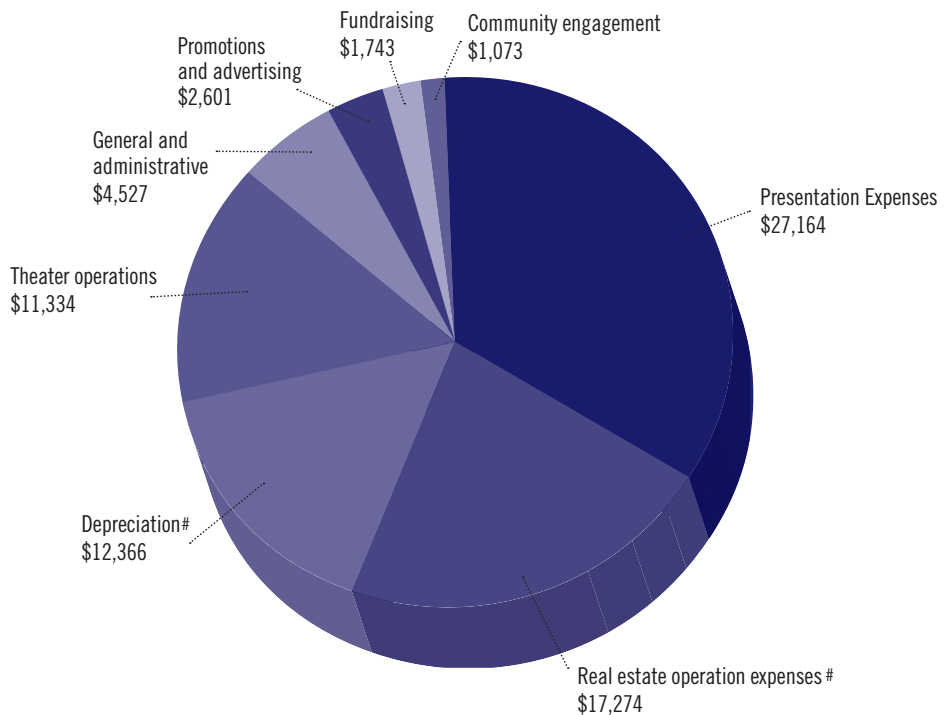
