DEAR FRIENDS

Our 2023-2024 fiscal year started off in dazzling fashion and kept shining!

It was undoubtedly a “marquee moment” setting the tone for our next era when we illuminated our new theater marquees and upgraded digital media network during the festive “Marquee Moments” street party headlined by multi-platinum artist Andy Grammer in September 2023. The event featured the debut of our nightly display that animates the full portfolio of digital assets throughout the District.

We then “eased on” into the 2023-2024 KeyBank Broadway Series with the pre-Broadway tour of *The Wiz*, followed by *Girl from the North Country*, *Mrs. Doubtfire*, *Funny Girl*, *Company*, the national tour launch of *Back to the Future The Musical*, and *MJ The Musical* entertaining our 44,000 season ticket holders in Cleveland.

And in Akron, more than 2200 season ticket holders enjoyed *Pretty Woman: The Musical*, *Mean Girls*, *The Cher Show*, and *CLUE* at E.J. Thomas Hall for the eighth year of our partnership with the University of Akron.

The Ohio General Assembly’s passing of a dedicated tax credit for theatrical productions in summer 2023 opens more possibilities for national tour

launches, pre-Broadway work, and show development, bolstering both Playhouse Square’s industry reputation and Cleveland’s economy.

Our Children’s Theater Series and Family Theater Day reached a new overall attendance record with more than 59,000 guests enjoying live performances designed for young audiences.

91,000 students from 30 counties across Ohio were able to experience theater through in-person matinees and on-demand streaming performances thanks to our Education Department’s work during the 2023-2024 fiscal year. Students from our Disney Musicals in Schools and Dazzle Awards programs experienced theater as well... as performers sharing their talents on our stages.

Playhouse Square is a proud member of the Northeast Ohio community and collaborating with partners around the city is always a highlight. We established a new affiliate company designation for professional Northeast Ohio arts organizations that are significant to our cultural life and have an established relationship with Playhouse Square, naming the venerable Karamu House as the first. The City Club of Cleveland became our eighth resident company as they moved into their new home in our District. And center stage met center court when we partnered with the Cleveland Cavaliers for their 2023-2024 NBA City Edition uniform.

Toward the end of the fiscal year, we could not pass up the opportunity to purchase Cleveland’s historic Greyhound station, sparking ideas to enliven the north side of our campus which we will share in the coming months. We continue to invest in amenities for theater guests, downtown workers and visitors, and look forward to the opening of The Bulkley Residences.

From a marquee moment to Cavaliers’ hoopla to the return of our beloved public tours, plus a once-in-a-

lifetime Total Eclipse of the Square event, the community was able to experience Playhouse Square in new ways, a concept we plan to continue in the years ahead.

Our work is made possible by our dedicated Board of Trustees, hard-working and devoted staff, passionate volunteers, generous donors who support our not-for-profit mission, and enthusiastic audiences. Many thanks to all.

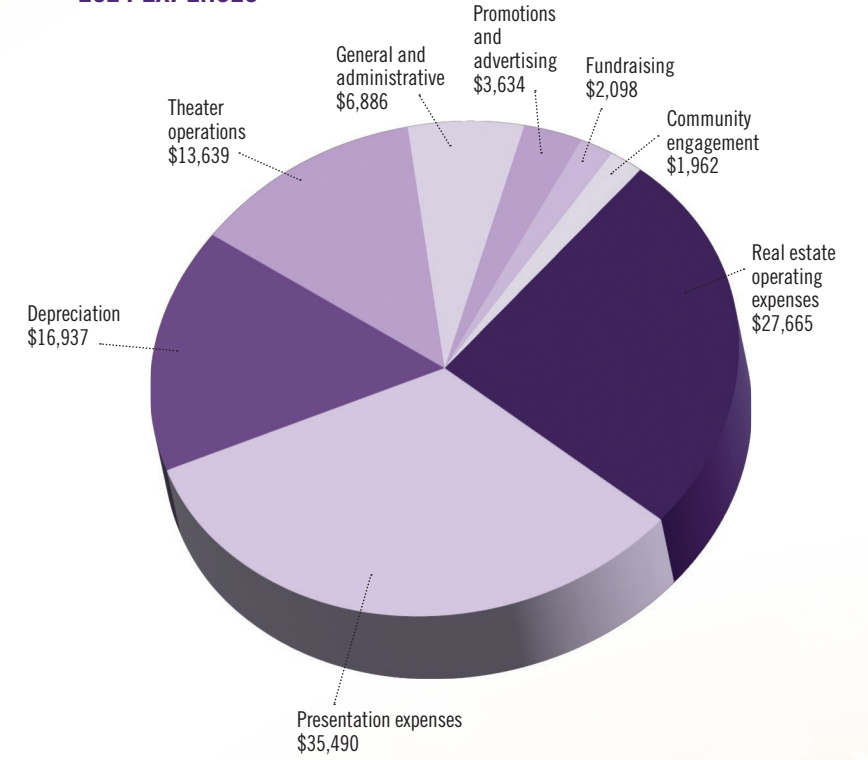
